## Announces Retirement From Louisville Metro Housing Authority



After more than 40 years with local government, long-time Louisville Metro Housing Authority's Executive Director, Tim Barry, is retiring. Barry was appointed to the top post at the Authority in 2001 by then mayor David L. Armstrong. During his tenure, he successfully helped LMHA secure funding for three HOPE VI development projects and, more recently, the Choice Neighborhood Initiative (CNI) redevelopment project that is currently underway in the Russell neighborhood.

"I've had a marvelous 40-year career with local government and the opportunity to work with five outstanding mayors and hundreds of equally outstanding local, state and federal government employees," said Barry. "I was also fortunate to work on a number of game changing projects that I hope improved the quality of life for those of us who live here."

Barry began his career with local government in 1977 as a

manager for the city's purchasing department. Over the years, he has worked on a number of large scale projects including the \$700 million Airport Improvement Project and the creation and development of Brightside—a public private partnership that is dedicated to uniting people in clean and green activities that beautify and foster pride in our community through volunteerism, planting, sustainability and education.

Since joining LMHA 17 years ago, Barry has helped the agency secure international recognition for the revitalization of Park DuValle—one of the most successful HOPE VI revitalization efforts in the country. Under his leadership, Louisville also became the only city to receive grants from all three CNI programs - planning, action activities and implementation – that are fueling many of the changes currently underway in the Russell neighborhood.

Mayor Greg Fischer says that Barry's

long and accomplished career has helped to make Louisville a better place.

"In his many years, Tim has been a model public servant who has always put the residents of Louisville first and has aspired to add to our quality of life with every project he tackled," said Mayor Fischer. "Our city's current momentum and enthusiasm would not be what it is today if not for the tireless work of Tim Barry."

Barry says that none of his accomplishments would have been possible without the daily efforts of the LMHA staff and the continued support of his family.

"I can't thank the LMHA staff enough for the support they've given me and the outstanding service they provide to our residents each day," said Barry. "Lastly, I want to thank my wife Melissa. Spending more time with her is the reason I look forward to retiring."

Barry's last day with the agency is April 20.

## Reily Reentry Project Helps Hundreds of Residents Take the First Step to a Clean Slate

**Organizers hope to hold other clinics in the near future**

The Louisville Urban League (LUL) held its first expungement clinic on Saturday, February 17<sup>th</sup> to help those who are eligible take the first steps to clearing their criminal record. The program is part of the Reily Reentry Project and helps participants complete and file the forms required to process the request.

Over 40 volunteers from Wyatt Tarrant and Combs, the Legal Aid Society and LUL served the hundreds of participants who lined up at Roosevelt Perry Elementary seeking assistance. While the group worked until late in the evening processing requests, staff were unable to serve everyone who attended this event due to high demand.

"We will help as many people as we can," said Sadiqa Reynolds, president and CEO of LUL. "We all make mistakes, and people deserve a second chance."

The Reily Reentry Project was made possible through a \$100,000 donation from LUL board member Stephen Reiley. LUL hopes to host another clinic in the near future.

## Expanded Community Health Center Planned for Russell Community

The Park DuValle Community Health Center will soon have a new state-of-the-art facility within the Russell Neighborhood. The new center will be located at the corner of 15<sup>th</sup> and Broadway. The approximately 9,000 square foot building will house and offer patients a variety of services including primary, women and pediatric care; dental services; behavioral health and health education.

Demolition of the current structures at the 15<sup>th</sup> and Broadway site will soon be underway. Construction of the new Center will begin in April and is projected for completion by December 2018. Be on the lookout for information on a groundbreaking that will be held this spring.

The facility will be located just blocks away from the new YMCA and Passport Health Plan's new Health and Well-Being Campus. Funding for this project is being provided by the U.S. Department of Health and Human Services.
