**Section 3 worker** means:

Any worker who currently fits **or when hired within the past five years** fit at least one of the following categories, as documented:

- (i) A resident of public housing or Section 8-assisted housing.
  - (ii) Income for the previous or annualized calendar year is below the income limit established by HUD (Individual annual **income at or below \$47,450**).
  - (iii) Employed by a Section 3 Business Concern.
  - (iv) A YouthBuild participant.

**FOR BUSINESS OWNERS. CHECK THE BOX THAT APPLIES TO YOUR BUSINESS.**

**Section 3 Business Concern** means:

A business concern meeting at least one of the following criteria, documented within the last six-month period:

- (i) It is at least 51 percent owned and controlled by low- or very low-income persons.
- (ii) Over 75 percent of the labor hours performed for the business over the prior three-month period are performed by Section 3 Workers.
- (iii) It is a business at least 51 percent owned and controlled by current public housing residents or residents who currently live in Section 8-assisted housing.
