Determinations of persons and businesses classified as Section 3 Workers and/or Section 3 Business Concerns (as per 24 CFR--PART 75.5 Definitions)

Section 3 worker means:

Any worker who currently fits **or when hired within the past five years** fit at least one of the following categories, as documented:

(i) A resident of public housing or Section 8-assisted housing.

(ii) Income for the previous or annualized calendar year is below the income limit established by HUD (Individual annual **income at or below \$47,450**).

(iii) Employed by a Section 3 Business Concern.

(iv) A YouthBuild participant.

FOR BUSINESS OWNERS. CHECK THE BOX THAT APPLIES TO YOUR BUSINESS.

Section 3 Business Concern means:

A business concern meeting at least one of the following criteria, documented within the last six-month period:

(i) It is at least 51 percent owned and controlled by low- or very low-income persons.

(ii) Over 75 percent of the labor hours performed for the business over the prior three-month period are performed by Section 3 Workers.

(iii) It is a business at least 51 percent owned and controlled by current public housing residents or residents who currently live in Section 8-assisted housing.
